A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO ARAL LAMPARA AT MUSIKA SOUND SYSTEM SERVICES FOR THE RENTAL OF SOUNDS AND LIGHTS WITH LED WALL FOR THE CULMINATING ACTIVITY ON LITERACY AND NUMERACY CUM 22ND SDO TABACO CITY FOUNDING ANNIVERSARY CELEBRATION

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:


