**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO POWER PRIME CAR SERVICE CENTER FOR THE SUPPLY & DELIVERY OF VARIOUS TIRES FOR VARIOUS HEAVY EQUIPMENT OWNED BY THE CITY GOVERNMENT OF TABACO**
