#### A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO EXCELUCENT EQUIPMENT CORP. FOR THE SUPPLY & DELIVERY OF VARIOUS VEHICLE PARTS FOR THE REPLACEMENT FOR HYUNDAI BACKHOE R140W-9S (WHEEL TYPE)
