A RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO LEGAZPI PREMIUM DEVELOPMENT CORPORATION FOR THE INSTALLATION/ REHABILITATION OF VARIOUS INFRASTRUCTURE PROJECTS (STREETLIGHTING PROJECT & ROADWAYS), VARIOUS BARANGAYS, TABACO CITY UNDER CONTRACT ID NO. 006-01-2025-INFRA-PB

WHEREAS, the City Government of Tabaco City posted the Invitation to Bid for the *Installation/ Rehabilitation of Various Infrastructure Projects (Streetlighting Project & Roadways), Various Barangays, Tabaco City under Contract ID No. 006-01-2025-INFRA-PB*, with an Approved Budget for the Contract (ABC) amounting to *Thirty-Eight Million Pesos (Php 38,000,000.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, three (3) contractors had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission of bids on February 17, 2025, the BAC received three (3) bids before the deadline of submission;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary "pass/fail" criteria, resulted as follows, to wit:
