A RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO JCM AMEG BUILDERS CORPORATION FOR THE IMPROVEMENT OF SANITARY LANDFILL, SITIO NAGSIPIT, BRGY. MARIROC, TABACO CITY UNDER CONTRACT ID NO. 011-02-2025-INFRA-PB

WHEREAS, the City Government of Tabaco City posted the Invitation to Bid for the *Improvement of Sanitary Landfill, Sitio Nagsipit, Brgy. Mariroc, Tabaco City under Contract ID No. 011-02-2025-INFRA-PB*, with an Approved Budget for the Contract (ABC) amounting to *Twenty Million Pesos (Php 20,000,000.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, three (3) contractors had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission of bids on March 03, 2025, the BAC received three (3) bids;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary “pass/fail” criteria, resulted as follows, to wit:

The following participating bidders received failed ratings in their Technical Component due to non-compliance with the requirements of the project, to wit:

1. Legazpi Premium Development Corp.
2. Kael Construction and Supply
