A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO SAKURA AUTOWORLD, INC. FOR THE SUPPLY & DELIVERY OF 12-UNITS BRAND NEW VAN (UTILITY VEHICLE), CITY MAYOR'S OFFICE AND CDRRMO, TABACO CITY UNDER CONTRACT ID NO. 012-02-2025-GOODS-PB

WHEREAS, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Supply & Delivery of 12-Units Brand New Van (Utility Vehicle), City Mayor's Office and CDRRMO, Tabaco City under Contract ID No. 012-02-2025-GOODS-PB* with an Approved Budget for the Contract (ABC) amounting to *Ten Million Eight Hundred Eighty-Seven Thousand Six Hundred Ninety-Two Pesos and Twenty-Eight Centavos (Php 10,887,692.28)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, one (1) supplier had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on March 10, 2025, the BAC received one (1) bid proposal;

WHEREAS, the opening and preliminary examination of bid, using non-discretionary "pass/fail" criteria, resulted as follows, to wit:

WHEREAS, the BAC immediately conducted the detailed evaluation of bid, which resulted as follows, to wit:


