A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO POWER PRIME CAR SERVICE CENTER FOR THE SUPPLY & DELIVERY OF VEHICLE BATTERY FOR VARIOUS TRANSPORTATION AND HEAVY EQUIPMENT OWNED BY THE CITY GOVERNMENT OF TABACO

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 25-02-0031** with an Approved Budget for the Contract (ABC) of **Php 190,500.00**;

WHEREAS, the BAC has posted in the PhilGEPS website the Request for Quotation for this procurement and sent the same to bonafide suppliers, indicating the specifications, quantity, ABC and the terms and conditions of the items to be procured;
