A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO JRE AGRIVET SUPPLY FOR THE SUPPLY & DELIVERY OF ANTI-RABIES VACCINE FOR RABIES PREVENTION/DOG VACCINATION
