A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO 189 BISTRO CATERING SERVICES FOR THE MEALS FOR THE MASS WEDDING FOR COUPLES DEPRIVED OF LIBERTY

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 25-02-0074** with an Approved Budget for the Contract (ABC) of **Php 64,000.00**;
