WHEREAS, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:



NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:


- a) To award the contract to **Magic 8 Enterprise** as the Supplier with the Lowest Calculated and Responsive Bid (LCRB) for this procurement.
