A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO O.R. ROCHA CONSTRUCTION & SUPPLY FOR THE JO-SUPPLY OF LABOR, MATERIALS AND EQUIPMENT FOR REPAIR/REHABILITATION OF MATAGBAC ROADWAYS AT MORAN ETATE SUBDIVISION BLOCK 26 LOT 1-10, BRGY. MATAGBAC, TABACO CITY

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 25-02-0101** with an Approved Budget for the Contract (ABC) of **Php 435,663.12**;
