A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO S.E.R. CONSTRUCTION AND DEVELOPMENT CORP. FOR THE JO-SUPPLY OF LABOR, MATERIALS AND EQUIPMENT FOR REPAIR/REHABILITATION OF MATAGBAC PATHWAYS AT BRGY. MATAGBAC, TABACO CITY
