A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO BRIGHTKEY DEVELOPMENT AND CONSTRUCTION FOR THE SUPPLY & DELIVERY OF VARIOUS TOOLS FOR OPERATION MAINTENANCE AT MRF AND SLF

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 25-02-0115** with an Approved Budget for the Contract (ABC) of **Php 73,015.00**;


WHEREAS, upon careful examination, validation and verification of all the documents submitted by the supplier with the lowest quoted price, its bid has been found to be responsive;
