A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO SCL POZO NEGRO EXCAVATOR AND PLUMBING SERVICES FOR THE SIPHONING OF SEPTIC TANK SLUDGE AT TABACO CITY CENTRAL TERMINAL, PAWA, TABACO CITY

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 25-02-0118** with an Approved Budget for the Contract (ABC) of **Php 96,000.00**;
