A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO PRECIOUSTAR CONSUMER GOODS TRADING FOR THE SUPPLY & DELIVERY OF VARIOUS OTHER AND JANITORIAL SUPPLIES

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Shopping under Section 52.1 (b)** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 25-02-0131** with an Approved Budget for the Contract (ABC) of **Php 354,215.00**;
