A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO DOMZ CONSTRUCTION SERVICES FOR THE JO-LABOR AND MATERIALS FOR THE FABRICATION AND INSTALLATION OF WINDOWS AND GRILLS WITH LOCK SAFETY, FIRE EXIT LADDER, INSTALLATION AND RENTAL OF SCAFFOLDING AND ROLL-UP

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 25-02-0143** with an Approved Budget for the Contract (ABC) of **Php 595,443.00**;

WHEREAS, the BAC has posted in the PhilGEPS website the Request for Quotation for this procurement and sent the same to bonafide suppliers, indicating the specifications, quantity, ABC and the terms and conditions of the items to be procured;
