
WHEREAS, upon careful examination, validation and verification of all the documents submitted by the supplier with the lowest quoted price, its bid has been found to be responsive;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:


- a) To award the contract to **Imperial Appliance Plaza** as the Supplier with the Lowest Calculated and Responsive Bid (LCRB) for this procurement.
