A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO LUCKY EDUCATIONAL SUPPLY INC. FOR THE SUPPLY & DELIVERY OF VARIOUS OFFICE SUPPLIES
