A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO ROVIPHIL CONTRACTOR FOR THE SUPPLY & DELIVERY OF VARIOUS HARDWARE SUPPLIES AND TOOLS
