A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO 189 BISTRO CATERING SERVICES FOR THE MEALS & VENUE FOR THE WOMEN'S SUMMIT 2025 - NATIONAL WOMEN'S MONTH CELEBRATION
