A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO 189 ENTERPRISES FOR THE SUPPLY & DELIVERY OF TOTE BAG TO BE GIVEN AS TOKEN FOR OPENING OF WOMEN'S MONTH CELEBRATION
