A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO 189 BISTRO CATERING SERVICES FOR THE MEALS FOR THE SCREENING COMMITTEE AND AWARDING PROGRAM FOR TABAQUEÑA K AWARD - ADVOCACY PROGRAM FOR WOMEN

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 25-02-0225** with an Approved Budget for the Contract (ABC) of **Php 71,000.00**;
