### A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO BRIGHTKEY DEVELOPMENT AND CONSTRUCTION FOR THE JO-LABOR, MATERIALS AND EQUIPMENT RENTAL FOR REPAIR/IMPROVEMENT OF LINE CANAL

**WHEREAS**, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 25-02-0235** with an Approved Budget for the Contract (ABC) of **Php 599,922.00**;

**WHEREAS**, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:


