**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO FIVE M HARDWARE AND CONSTRUCTION SUPPLY FOR THE REHAB/REPAIR OF CHILD DEVELOPMENT CENTER AT VARIOUS BRGYS.**
