A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO FIVE M HARDWARE AND CONSTRUCTION SUPPLY FOR THE SUPPLY AND DELIVERY OF VARIOUS CONSTRUCTION MATERIALS AND SUPPLIES FOR THE REPAIR AND MAINTENANCE WORK OF VARIOUS PUBLIC BLDG. (CITY HALL COMPLEX, HIRAYA AGRICULTURE OFFICE, SAN ANTONIO EVACUATION AND LYING-IN CLINIC, CEO TEMPORARY OFFICE, ETC.

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 25-02-0240** with an Approved Budget for the Contract (ABC) of **Php 599,625.00**;
