A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO KING JAMES ENTERPRISES FOR THE SUPPLY & DELIVERY VARIOUS HARDWARE SUPPLIES FOR THE INTEGRATED TRAINING PROGRAM FOR "PADYAK" DRIVERS: UPHOLSTERY MAKING

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 25-02-0264** with an Approved Budget for the Contract (ABC) of **Php 392,460.00**;
