A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO GAKKEN (PHILIPPINES) INC. FOR THE SUPPLY & DELIVERY OF DIGITAL COPIER FOR SP SECRETARY OFFICE
