**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO FIVE M HARDWARE AND CONSTRUCTION SUPPLY FOR THE JO-LABOR & MATERIALS FOR THE REPAIR AND MAINTENANCE OF CHILDREN DEVELOPMENT CENTER**
