**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO ARAL LAMPARA AT MUSIKA SOUND SYSTEM SERVICES FOR THE RENTAL OF SOUND & LIGHTS WITH LED WALL, ACRYLIC STAGE AND ROOFING FOR 3 DAY CELEBRATION OF THE 24TH CITYHOOD ANNIVERSARY OF TABACO CITY**
