A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO MAGIC 8 ENTERPRISE FOR THE SUPPLY & DELIVERY OF VARIOUS SUPPLIES

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Shopping under Section 52.1 (b)** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 25-02-0168** with an Approved Budget for the Contract (ABC) of **Php 74,005.34**;

WHEREAS, the BAC has posted in the PhilGEPS website the Request for Quotation for this procurement and sent the same to bonafide suppliers, indicating the specifications, quantity, ABC and the terms and conditions of the items to be procured;

WHEREAS, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:

WHEREAS, upon careful examination, validation and verification of all the documents submitted by the supplier with the lowest quoted price, Wellness Plus Health Care Products Trading was found to be non-compliant with the requirements of the project for not submitting the required Certificate of Tax Clearance; hence, it's bid was disqualified;

WHEREAS, the BAC proceeded with the examination, validation and verification of all the documents submitted by the supplier with the Second lowest quoted price, Magic 8 Enterprise, and its bid was found to be responsive with the requirements of the project.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To award the contract to **Magic 8 Enterprise** as the Supplier with the Lowest Calculated and Responsive Bid (LCRB) for this procurement.
- b) To recommend to the City Mayor of Tabaco the award of contract to **Magic 8 Enterprise** in the amount of **Sixty-Four Thousand Seven Hundred Forty-Three Pesos and Fifty Centavos (Php 64,743.50)**.
