A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO LIGHTSUP MARKETING CORPORATION FOR THE SUPPLY & DELIVERY OF RAIN BOOTS AND RAINCOATS FOR CENRO PERSONNEL

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 25-02-0251** with an Approved Budget for the Contract (ABC) of **Php 135,000.00**;
