**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO KING JAMES ENTERPRISES FOR THE SUPPLY & DELIVERY OF VARIOUS ELECTRICAL SUPPLIES FOR INTEGRATED TRAINING PROGRAM FOR "PADYAK" DRIVERS: SOLAR LIGHT INSTALLATION, MAINTENANCE SERVICES AND TRAFFIC SAFETY AWARENESS**
