A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO JAMESTOWN BUILDERS & CONSTRUCTION SUPPLIES FOR THE JO-LABOR & MATERIALS - FABRICATION AND INSTALLATION REPAIR AND MAINTENANCE OF CITY TERMINAL AT PAWA TABACO CITY, CR PARTITION AND OTHER ACCESSORIES, WATER PROOFING, PAINTING CARPENTRY, CONCRETE WORKS AND CHIPPING WORKS

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 25-03-0346** with an Approved Budget for the Contract (ABC) of **Php 240,477.00**;

WHEREAS, the BAC has posted in the PhilGEPS website the Request for Quotation for this procurement and sent the same to bonafide suppliers, indicating the specifications, quantity, ABC and the terms and conditions of the items to be procured;

WHEREAS, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:
