A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO PLC TRADING INC. FOR THE SUPPLY & DELIVERY OF INFANT & TODDLERS' MEASURING MAT FOR ANTHROPOMETRIC TOOL FOR OPERATION TIMBANG PLUS

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Shopping under Section 52.1 (b)** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 25-03-0432** with an Approved Budget for the Contract (ABC) of **Php 102,000.00**;
