A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO CAR ACCESS AUTO SUPPLY & GEN. MDSE. INC. FOR THE SUPPLY & DELIVERY OF VEHICLE PARTS AND ACCESSORIES FOR LONKING BACKHOE AND VEHICLE WITH PLATE NO/CONDUCTION STICKERS SJH-118 AND F1C-028

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 25-03-0446** with an Approved Budget for the Contract (ABC) of **Php 60,736.70**;
