#### A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO QUALIGEN PHARMACY FOR THE SUPPLY & DELIVERY OF VARIOUS MEDICAL AND DENTAL EQUIPMENT
