**A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO SFM SALES CORPORATION FOR THE SUPPLY & DELIVERY OF 2-UNITS BRAND NEW MOTOR VEHICLES, GENERAL SERVICES OFFICE (GSO), TABACO CITY UNDER CONTRACT ID NO. 019-03-2025-GOODS-PB**

**WHEREAS**, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Supply & Delivery of 2-Units Brand New Motor Vehicles, General Services Office (GSO), Tabaco City under Contract ID No. 019-03-2025-GOODS-PB* with an Approved Budget for the Contract (ABC) amounting to *Two Million Nine Hundred Thousand Pesos (Php 2,900,000.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

**WHEREAS**, in response to the said posting, one (1) supplier had shown interest to participate by purchasing the bidding documents;

**WHEREAS**, during the deadline for submission and opening of bids on April 14, 2025, the BAC received one (1) bid proposal;

**WHEREAS**, the opening and preliminary examination of bid, using non-discretionary “pass/fail” criteria, resulted as follows, to wit:

**WHEREAS**, the BAC immediately conducted the detailed evaluation of bid, which resulted as follows, to wit:



**NOW, THEREFORE**, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare the bid of **SFM SALES CORPORATION** as the Single Calculated Responsive Bid (SCRB) for the *Supply & Delivery of 2-Units Brand New Motor Vehicles, General Services Office (GSO), Tabaco City under Contract ID No. 019-03-2025-GOODS-PB*; and
- b) To recommend to the City Mayor of Tabaco the award of contract to **SFM SALES CORPORATION** in the amount of *Two Million Four Hundred Sixty-Five Thousand Pesos (Php 2,465,000.00)*.




