A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO 4KMB GENERAL MERCHANDISE FOR THE SUPPLY & DELIVERY OF ADULT MILK, MATERNAL MILK, AND GROWING UP MILK FOR FEEDING SUPPLEMENTATION PROGRAMS, GAD-CITY NUTRITION OFFICE, TABACO CITY UNDER CONTRACT ID NO. 020-04-2025-GOODS-PB-R1

WHEREAS, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Supply & Delivery of Adult Milk, Maternal Milk, and Growing Up Milk for Feeding Supplementation Programs, GAD-City Nutrition Office, Tabaco City under Contract ID No. 020-04-2025-GOODS-PB-R1* with an Approved Budget for the Contract (ABC) amounting to *Two Million Nine Hundred Sixty-One Thousand Eighty Pesos (Php 2,961,080.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, one (1) supplier had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on May 27, 2025, the BAC received one (1) bid proposal;

WHEREAS, the opening and preliminary examination of bid, using non-discretionary “pass/fail” criteria, resulted as follows, to wit:

WHEREAS, the BAC immediately conducted the detailed evaluation of bid, which resulted as follows, to wit:






- a) To declare the bid of *4KMB GENERAL MERCHANDISE* as the Single Calculated Responsive Bid (SCRB) for the *Supply & Delivery of Adult Milk, Maternal Milk, and Growing Up Milk for Feeding Supplementation Programs, GAD-City Nutrition Office, Tabaco City under Contract ID No. 020-04-2025-GOODS-PB-R1*; and
- b) To recommend to the City Mayor of Tabaco the award of contract to *4KMB GENERAL MERCHANDISE* in the amount of *Two Million Nine Hundred Forty Thousand Three Hundred Thirty-Seven Pesos and Seventy-Five Centavos (Php 2,940,337.75)*.


