**A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO PLC TRADING INC. FOR THE SUPPLY & DELIVERY OF MULTIVITAMINS FOR THE MICRONUTRIENT SUPPLEMENTATION OF 6-59 MONTHS' OLD CHILDREN, GAD-CITY NUTRITION OFFICE, TABACO CITY UNDER CONTRACT ID NO. 022-04-2025-GOODS-PB**

**WHEREAS**, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Supply & Delivery of Multivitamins for the Micronutrient Supplementation of 6-59 Months' Old Children, GAD-City Nutrition Office, Tabaco City under Contract ID No. 022-04-2025-GOODS-PB* with an Approved Budget for the Contract (ABC) amounting to *One Million Five Hundred Forty-Two Thousand One Hundred Fifty Pesos (Php 1,542,150.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

**WHEREAS**, in response to the said posting, one (1) supplier had shown interest to participate by purchasing the bidding documents;

**WHEREAS**, during the deadline for submission and opening of bids on April 22 2025, the BAC received one (1) bid proposal;

**WHEREAS**, the opening and preliminary examination of bid, using non-discretionary "pass/fail" criteria, resulted as follows, to wit:

**WHEREAS**, the BAC immediately conducted the detailed evaluation of bid, which resulted as follows, to wit:



It was found that *PLC Trading Inc.* is substantially compliant with the requirements of the foregoing procurement and its bid is responsive;

**NOW, THEREFORE**, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:


- To declare the bid of *PLC TRADING INC.* as the Single Calculated Responsive Bid (SCRB) for the *Supply & Delivery of Multivitamins for the Micronutrient Supplementation of 6-59 Months' Old Children, GAD-City Nutrition Office, Tabaco City under Contract ID No. 022-04-2025-GOODS-PB*; and
- To recommend to the City Mayor of Tabaco the award of contract to *PLC Trading Inc.* in the amount of *One Million Four Hundred Forty-Eight Thousand Eight Hundred Eighty-Seven Pesos and Eighty Centavos (Php 1,448,887.80)*.


