BAC Resolution No. 2025-2Q-05- 0569

A RESOLUTION DECLARING THE LOWEST CALCULATED RESPONSIVE BID (LCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO MGM MEDICAL SUPPLIES AND GENERAL MERCHANDISE FOR THE SUPPLY & DELIVERY OF DRUGS & MEDICINES, VISITA-HACIENDA SMLIK, SAN MIGUEL ISLAND, TABACO CITY UNDER CONTRACT ID NO. 023-04-2025-GOODS-PB

WHEREAS, the City Government of Tabaco posted the Invitation to Bid for the *Supply & Delivery of Drugs & Medicines, Visita-Hacienda SMLIK, San Miguel Island, Tabaco City under Contract ID No. 023-04-2025-GOODS-PB*, with an Approved Budget for the Contract (ABC) amounting to *Three Million Four Hundred Eighty-Seven Thousand Three Hundred Twenty-One Pesos and Forty Centavos (Php 3,487,321.40)* in the PhilGEPs website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, three (3) suppliers have shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on April 23, 2025, the BAC received three (3) bid proposal;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary "pass/fail" criteria, resulted as follows, to wit:

The bid of PLC Trading Inc. received a Failed rating in its Technical Component due to non-compliance with the requirements of the project.

WHEREAS, the BAC immediately conducted the detailed evaluation of bids of those which were rated Passed, and the result was as follows, to wit:

WHEREAS, per post-qualification conducted by the BAC Technical Working Group (TWG) of the bid of **BCVR Prime Enterprise**, the bidder with lowest calculated bid, involving careful examination, verification, validation and ascertainment of all statements and representations made in relation to its bid, it was found to be non-compliant and non-responsive to the requirements and conditions of the project. Hence, its bid was declared post-disqualified (*BAC Resolution No. 2025-2Q-05-0509, dated May 09, 2025*);


WHEREAS, the BAC proceeded with the post-qualification of the bidder with second lowest calculated bid, **MGM Medical Supplies and General Merchandise**, involving the verification and validation of its legal, technical and financial documents. It was found that the bid of **MGM Medical Supplies and General Merchandise** is substantially compliant with the requirements of the foregoing procurement and its bid is responsive;

NOW, THEREFORE, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare the bid of *MGM Medical Supplies and General Merchandise* as the Lowest Calculated Responsive Bid (LCRB) for the *Supply & Delivery of Drugs & Medicines, Visita-Hacienda SMLIK, San Miguel Island, Tabaco City under Contract ID No. 023-04-2025-GOODS-PB*; and
- b) To recommend to the City Mayor of Tabaco the award of contract to *MGM Medical Supplies and General Merchandise* in the amount of *Two Million Seven Hundred Ninety-Five Thousand Nine Hundred Twenty-Six Pesos and Twenty-Eight Centavos (Php 2,795,926.28)*.


