BAC Resolution No. 2025-2Q-06- 0710

A RESOLUTION DECLARING THE LOWEST CALCULATED RESPONSIVE BID (LCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO OMAX ENTERPRISES FOR THE SUPPLY & DELIVERY OF BOND PAPERS FOR THE EXECUTIVE AND LEGISLATIVE DEPARTMENTS, GENERAL SERVICES OFFICE, TABACO CITY UNDER CONTRACT ID NO. 026-05-2025-GOODS-PB

WHEREAS, the City Government of Tabaco posted the Invitation to Bid for the *Supply & Delivery of Bond Papers for the Executive and Legislative Departments, General Services Office, Tabaco City under Contract ID No. 026-05-2025-GOODS-PB*, with an Approved Budget for the Contract (ABC) amounting to *One Million Five Hundred Forty-Two Thousand Five Hundred Seventy-Seven Pesos and Eighty Centavos (Php 1,542,577.80)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, two (2) suppliers have shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on May 28, 2025, the BAC received two (2) bid proposal;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary “pass/fail” criteria, resulted as follows, to wit:

WHEREAS, the BAC immediately conducted the detailed evaluation of bids of those which were rated Passed, and the result was as follows, to wit:



WHEREAS, the BAC Technical Working Group (TWG) conducted the post-qualification of *Omax Enterprises*, the bidder with lowest calculated bid, involving the verification and validation of its legal, technical and financial documents. It was found that *Omax Enterprises* is substantially compliant with the requirements of the foregoing procurement and its bid is responsive;

NOW, THEREFORE, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare the bid of *OMAX ENTERPRISES* as the Lowest Calculated Responsive Bid (LCRB) for the *Supply & Delivery of Bond Papers for the Executive and Legislative Departments, General Services Office, Tabaco City under Contract ID No. 026-05-2025-GOODS-PB*; and
- b) To recommend to the City Mayor of Tabaco the award of contract to *OMAX ENTERPRISES* in the amount of *One Million Three Hundred Thirty-Four Thousand Six Hundred Ninety-Five Pesos (Php 1,334,695.00)*.
