A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO PIXEL8 WEB SOLUTIONS AND CONSULTANCY FOR THE SUPPLY & DELIVERY OF IT SUPPLIES FOR VARIOUS OFFICES, GENERAL SERVICES OFFICE, TABACO CITY UNDER CONTRACT ID NO. 029-05-2025-GOODS-PB

WHEREAS, the City Government of Tabaco posted the Invitation to Bid for the *Supply & Delivery of IT Supplies for Various Offices, General Services Office, Tabaco City under Contract ID No. 029-05-2025-GOODS-PB*, with an Approved Budget for the Contract (ABC) amounting to *One Million Four Hundred Twenty-Three Thousand Four Hundred Twenty-Two Pesos (Php 1,423,422.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, one (1) supplier has shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on June 11, 2025, the BAC received one (1) bid proposal;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary "pass/fail" criteria, resulted as follows, to wit:

WHEREAS, the BAC immediately conducted the detailed evaluation of bids of those which were rated Passed, and the result was as follows, to wit:

WHEREAS, the BAC Technical Working Group (TWG) conducted the post-qualification of *Pixel8 Web Solutions & Consultancy*, the bidder with single calculated bid, involving the verification and validation of its legal, technical and financial documents. It was found that *Pixel8 Web Solutions & Consultancy* is substantially compliant with the requirements of the foregoing procurement and its bid is responsive;

NOW, THEREFORE, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare the bid of *Pixel8 Web Solutions & Consultancy* as the Single Calculated Responsive Bid (SCRB) for the *Supply & Delivery of IT Supplies for Various Offices, General Services Office, Tabaco City under Contract ID No. 029-05-2025-GOODS-PB*; and
- b) To recommend to the City Mayor of Tabaco the award of contract to *Pixel8 Web Solutions & Consultancy* in the amount of *One Million Three Hundred Thirty-Three Thousand Five Hundred Twenty-Four Pesos (Php 1,333,524.00)*.




