A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO IULEKZ AGRI INPUTS MARKETING FOR THE SUPPLY & DELIVERY OF VERMI COMPOST FOR FARMERS AND OTHER ORGANIC STAKEHOLDERS

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Shopping under Section 52.1 (b)** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 25-02-0252** with an Approved Budget for the Contract (ABC) of **Php 299,600.00**;
