A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO JVJ APPLIANCES TRADING FOR THE SUPPLY & DELIVERY OF FLOOR MOUNTED AIR CONDITIONER FOR LIBRARY OFFICE


