A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO 3GX COMPUTER & IT SOLUTIONS TECHNOSHOP FOR THE SUPPLY & DELIVERY OF COMPUTER INK AND SSD FOR ALTERNATIVE LEARNING PROGRAM (TABACO CITY LITERACY HUB)

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Shopping under Section 52.1 (b)** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 25-03-0359** with an Approved Budget for the Contract (ABC) of **Php 72,785.00**;

WHEREAS, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:




WHEREAS, upon careful examination, validation and verification of all the documents submitted by the supplier with the lowest quoted price, its bid has been found to be responsive;


