A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO EBB CONSUMER GOODS TRADING FOR THE SUPPLY & DELIVERY OF VARIOUS PLASTIC BAGS AND GARBAGE BAGS FOR OPERATIONALIZATION OF NUTRITION OFFICE AND TABACO F1K ++ NUTRI CENTER

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Shopping under Section 52.1 (b)** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 25-03-0382** with an Approved Budget for the Contract (ABC) of **Php 675,855.00**;


WHEREAS, upon careful examination, validation and verification of all the documents submitted by the supplier with the lowest quoted price, its bid has been found to be responsive;
