A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO 4KMB GENERAL MERCHANDISE FOR THE SUPPLY & DELIVERY OF WHITE RICE FOR INGREDIENTS FOR COMPLEMENTARY FOOD FOR 6-23 MONTHS OLD FEEDING SUPPLEMENTATION (DIETARY SUPPLEMENTATION)
