A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO EBB CONSUMER GOODS TRADING FOR THE SUPPLY & DELIVERY OF FOOD HANDLING SUPPLIES (PERSONAL PROTECTIVE EQUIPMENT (PPE) FOR THE OPERATIONALIZATION OF NUTRITION OFFICE AND TABACO F1K++ NUTRI CENTER

WHEREAS, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:


