#### A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO LIXSOURCE TRADING FOR THE SUPPLY & DELIVERY OF VARIOUS DRUGS AND MEDICINES FOR MCK
