A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO FIVE M HARDWARE AND CONSTRUCTION SUPPLY FOR THE SUPPLY & DELIVERY OF ELECTRICAL SUPPLIES FOR THE MAINTENANCE/REPLACEMENT OF ELECTRICAL FIXTURES AND FEEDER WIRES AT CITY HALL COMPLEX, SATELLITE OFFICE AND DISTRIBUTION LINES ALONG HACIENDA SAN MIGUEL ISLAND, TABACO CITY

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 25-03-0482** with an Approved Budget for the Contract (ABC) of **Php 599,000.00**;

WHEREAS, the BAC has posted in the PhilGEPS website the Request for Quotation for this procurement and sent the same to bonafide suppliers, indicating the specifications, quantity, ABC and the terms and conditions of the items to be procured;

WHEREAS, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:
